### **ENABLON METRICS PROJECT EXPERIENCE**

Enablon Implementation/Support for a Major Food & Beverage Company: *Worked with and supported the implementation of the Metrics application and load of historical metrics data. Also worked with client to design a process to simplify the data collection for their contractors to then be able to import the data into Enablon. Responsibilities included working with client to understand existing processes and information gathered to create list of metrics to gather, configuring the indicators required for the data capture including setting up conditionality and validity checks of data entered, creating and documenting a design for client approval, designing and configuring the data import process, and providing support during UAT and go-live.*

Enablon Support for a Major Manufacturing Company: *Worked with a small team to provide support for the Metrics, Audit, Inspection, and Health & Safety modules within Enablon. Initial responsibilities included assisting the Enablon administration team with data issues such as adding or removing Entities from Metrics Campaigns, assisting in the consolidation of data in Metrics, adding new fields in Enablon to track data that was not previously being tracked, and updating/building integrations to manage data from external systems. While supporting the client, end user adoption increased significantly, allowing the administrative team to have access to more and better data. Also assisted admin team in reporting their data with PowerBI, saving hundreds of man hours every month building reports for global management.*
